COMBINED ANNUAL BUDGET AND APPROPRIATIONS ORDINANCE FOR PARK PURPOSES FOR FISCAL YEAR 2022-2023

WHEREAS, the Illinois Municipal Budget Law, Illinois Revised statues, Chapter 85, Section 801, et seq., as amended, requires all Illinois Municipal corporations, as broadly defined therein, to adopt a combined annual budget and appropriations ordinance, specifying the objects and purposes of expenditures; and such statues provide procedures for the passage of a budget and appropriations ordinance and tax levy ordinance, and

WHEREAS, pursuant to the above and other statues, an ordinance has been prepared in tentative form and made available for public inspection at least thirty (30) days prior to the adoption thereof, and a public hearing on a said budget and appropriations ordinance had been held prior to final action hereon, and notice of said hearing was published within the District.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the York Center Park District and of the expenditures they're from being and the same hereby is adopted as the budget of the district for the fiscal year beginning May 1, 2022, and ending April 30, 2023, the same sums are hereby appropriated and necessary to defray the said expenses and liabilities of the Park District, for the object and purposes indicated, for said fiscal year.

Section1. The following attached as Exhibit "A" is an estimate of revenue and cash available for the fiscal year ending April 30, 2023.

- Section 2. Except as otherwise provided by law, no further appropriations shall be made at any other time within such fiscal year, provided that this board may form time to make transfers between the various items in a fund, or appropriations in excess of those authorized by the budget in order to meet an immediate and unforeseen emergency by a two-thirds (2/3) vote of all commissioners present and voting, as provided by Illinois Revised Statute for the original adoption of a budget and appropriation ordinance; provide that nothing in this section shall be construed to permit transfer of funds required by law to be kept separate.
- Section 3. A copy of this ordinance in tentative form has been available for public inspection at the District for thirty (30) days prior to the public hearing and notice of said hearing was given at least one (1) week prior thereto as required by law.
- Section 4. All unexpended balances of any item or items of any general application made in this Ordinance, may be expended in making up any insufficiency in appropriation of any like appropriation made by this Ordinance.
- Section 5. All miscellaneous receipts of revenue from all sources not herein expressly reserved or appropriated shall be available to pay appropriations herein provided for, not payable out of specific funds herein appropriated. That all unexpended balances of annual appropriation of previous fiscal years are hereby appropriated.
- Section 6. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.
